## OFFICE ORDER

The Director, ICAR-Directorate of Medicinal and Aromatic Plants Research, Boriavi, Anand, Gujarat has been pleased to appoint Dr. Deepak Soni, (M.B.B.S), 1, Shreeji Clinic, Kamla Park Road, B/h. Town Hall, Anand-388001 as Authorized Medical Attendant (AMA) for the period of one year w.e.f. 06.04.2023 to 05.04.2024 for providing medical treatment to the employees of ICAR-DMAPR, Boriavi, Anand and their family members residing within a radius of 16 km at Anand & Boriavi and other nearby localities, subject to the following terms and conditions:

1. The consultation and injection fee will be charged at the rates prescribed under the Central Service (Medical Attendance) Rules, 1944.
2. Utmost economy may be exercised in prescribing medicines where cheaper medicine equal/therapeutic values are available only those should be prescribed. AMA should indicate their Registration Number while signing bills. Tests/ Examination etc. should be carried out only at Government/recognized Hospitals at the prescribed rates.
3. Medicines should not be prescribed for all the 10 days at a stretch. The daily dosage should be indicated in the prescription.
4. If the treatment is expected to be prolonged requiring many consultations and several injections spread over a period of more than 10 days, the patient should be referred to the out-patient department of a Government/recognized hospital at the earliest.
5. Cases of Medical treatment requiring hospitalization have to be referred to Government/recognized hospital.
6. His nomination will stand terminated when the CGHS dispensary is opened for that area.

7. The Director, ICAR-DMAPR reserves the right to terminate the appointment if the service of AMA are no longer required or otherwise without assigning any reasons or giving notice.
